


The Toshiba TLP109 mini-flat coupler is a small-outline coupler suitable for surface-mount assembly.

The TLP109 consists of a high-output-power GaAlAs light emitting diode optically coupled to a high-speed photodiode-transistor chip. The TLP109 is housed in the 6-pin SO package and guarantees a creepage distance of ≥ 5.0 mm, a clearance of ≥ 5.0 mm and an insulation thickness of ≥ 0.4 mm. Therefore, the TLP109 meets the reinforced insulation class requirements of international safety standards.














Figure 1 Device Orientation

Device orientation in the recesses is as shown in Figure 1.

The start of the tape has 50 or more empty holes. The end of tape has 50 or more empty holes and two empty turns only for a cover tape.




Figure 2 Tape Forms

- (2) Dimensions: The tape dimensions are as shown in Figure 2 and Table 3.




Figure 3 Reel Form

Either one reel or five reels of photocoupler are packed in a shipping carton.


5. Label Indication
